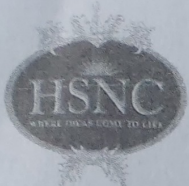





3. Chairman Mr. Anil Harish welcomed all members for the Governing Body meeting.

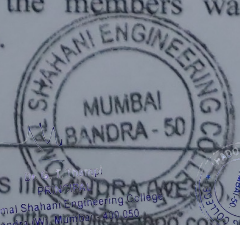
4. Principal G.T. Thampi circulated the copy of the agenda, Action taken report. The chairman accepted it and started discussion on the agenda.

Balance sheet was presented/projected to all the members and approved.


9. Item No 6: Budget 2023-24
